## HOLIDAY BOOKING CONDITIONS (Important)

- 1] Dancing** is an aerobic and energetic activity and as such participants must be aware that they take part at their own risk, fully understanding that **any consequential injury or loss is their own responsibility and Jivestyle cannot nor will be held liable.**
- 2]** Upon receipt of your deposit and booking form, these will represent that a binding contract exists between you, all other members of your group and *Jivestyle*.
- 3] Your Balance** must be paid at least 8 weeks prior to departure date. If the balance is not paid on time, we reserve the right to cancel your booking and retain the deposit. For bookings made within 8 weeks of the departure date, the full cost of the booking must be paid at the time of booking and will be subject to our cancellations policy stated below.
- 4] Holiday Insurance:** It is an absolute necessity that all persons (including those within your group booking) that are joining our holiday, be responsible for their own insurance needs. This is entirely your own responsibility and as such, each member of your group **MUST** take out adequate holiday insurance for the full duration of the holiday. Such insurance cover must also offer a 24 hour emergency telephone, repatriation service and holiday cancellation cover. Your booking has been made on this basis and you fully understand that *Jivestyle* cannot be held liable under any circumstance. Should you fail to take out adequate insurance cover we will, in an emergency, offer all reasonable assistance and you understand that you will be responsible for any costs involved as a consequence of your failure to take out appropriate insurance cover.
- 5] Flights:** Dancers need to book their own flights appropriate to the holiday destination. Your contract for the flight is with the relevant airline who, following the booking, issue a booking confirmation number in respect of the passengers detailed under the said confirmation number. It is your responsibility to ensure that you arrive at the stated time to board all flights and the conditions of carriage of that carrier apply. Should you miss a flight for any reason, it is your own responsibility to resolve and *Jivestyle* will neither accept liability or responsibility should such an occurrence arise. *Jivestyle* will, however, offer you all assistance where possible.
- 6] Cancellations** made up to 8 weeks before the holiday period, may be subject to a cancellation fee of £100 per person. Any cancellations within the final 8 weeks before the holiday start date will be subject to a complete loss of holiday fees paid, any refunds will be solely at the discretion of *Jivestyle*. (Your insurance should cover such an eventuality)
- 7] Transfers:** For the convenience of dancers who book it in advance, *Jivestyle* will, where possible, arrange a coach transfer from airport to Hotel and on return from Hotel to airport. A nominal charge (that we will make known to you at time of booking) will be made for this return transfer. Please understand that this service is subject to flight arrivals/departures coinciding conveniently. If requested we will endeavour to make other appropriate arrangements on your behalf.
- 8]** Details of this dance holiday have been published by *Jivestyle* in good faith and are based upon arrangements made with the relevant Hotels. *Jivestyle* however do reserve the right to amend or alter any of the information that they may publish in connection with these dance holidays.
